**Notification Concerning Revision of Forecast of Results for the Fiscal Year Ending March 2006 (Consolidated)**

Plaza Create has revised the forecast of results for the interim period of the fiscal year ending March 2006 (April 1, 2005 to March 31, 2006) released by the Company on May 20, 2005 based on the trend in recent results and other factors. An explanation of the revision is described below.
